Participants will be required to bring their own computers with the mentioned softwares installed. By the way, a mouse will be helpful in editing your images.

You will surely get the most from this workshop and enjoy the experience more if you already have a prior basic understanding of exposure and how cameras work. Aside from that, this trip is a venue to gain new friends and experience great adventures.


